#### **Summary of Principal's Update - Johnny Bush**

- Many thanks to the Foundation and all Plant parents for all that you do to help make Plant such an amazing school.
- Please remember that teachers and staff are parents and people too, who have the same concerns and stresses as you.
- Plant currently has 1885 students attending in-person/brick and mortar, plus 595 e-learners, for a total of 2480 students thus far this fall.
- Teachers are responsible for in-person learning, e-learning, and now also quarantine learning, so they have a lot on their plates.
- In person students are doing a good job of following the CDC guidelines as much as they can, given our close quarters.
- We cannot control what students do when they are not at school.
- When a student tests positive, anywhere from 4-8 students that sit near him/her in each of his/her classes must be quarantined for 14 days (per district policy). It is not punitive – these students are marked as being on "school business," and they cannot come back in less than 14 days, even with a negative test result.
- Plant, Newsome, Steinbrenner and Sickles are experiencing the most positive cases. As of today, Plant has had 19 students and three adults report that they tested positive.
- Please support quarantining efforts and do not shame anyone who reports testing positive.
- Students and their families need to work with teachers directly to formulate quarantine learning plans. If there are any issues, involve counselors and administrators.
- Any student who cannot take the October 14<sup>th</sup> PSAT because they are quarantined will be allowed to take it in late January 2021. Proof of quarantine will be required and will be provided by administration.

- The administration is working with the PTSA to develop a student video that will promote health and safety and following CDC guidelines in and out of school.
- With the upcoming election, we are trying to keep politics out of the classrooms.
